If You Participate in Certain Government Assistance Programs Such As SNAP, Medicaid, WIC, or Other Programs

Federal Assistance Programs

You are eligible for the ACP if you (or someone in your household) participate in one of these programs:

- Supplemental Nutrition Assistance Program (SNAP), formerly known as Food Stamps
- Medicaid
- Special Supplemental Nutrition Program for Women, Infants, and Children (WIC)
- Supplemental Security Income (SSI)
- Federal Public Housing Assistance (FPHA)
- Veterans Pension and Survivors Benefit
- Free and Reduced-Price School Lunch Program or School Breakfast Program, including at U.S. Department of Agriculture (USDA) Community Eligibility Provision schools
- Received a Federal Pell Grant in the current award year

You may need to show a card, letter, or official document as [proof that you participate](#) in one of these programs when you apply for the ACP.

Tribal Assistance Programs

If you live on qualifying Tribal lands, you are eligible for the ACP if your household income is at or below 200% of the Federal Poverty Guidelines, or if you (or someone in your household) participate in:

- Any of the federal assistance programs listed above
- Bureau of Indian Affairs General Assistance
- Head Start (only households meeting the income qualifying standard)
- Tribal Temporary Assistance for Needy Families (Tribal TANF)
- Food Distribution Program on Indian Reservations

You may have to show proof of participation, like a benefit letter or official document, when you apply for the ACP. Learn more about the [Tribal Benefit](#).

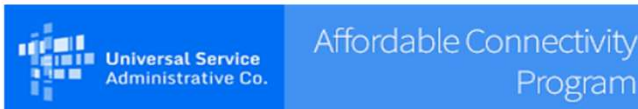

How to Sign Up with a Provider

1. Contact a participating [internet company](#) to pick a service plan and ask to sign up for the ACP to start receiving the benefit.

If you are interested in a connected device, [click here](#) for a list of companies that offer connected devices. Not all companies participating in the program are offering connected devices. You will need to enroll with a company to receive your broadband AND device benefit.

2. Tell the provider that you have been approved by the Universal Service Administrative Company (USAC).
3. **IMPORTANT TIP:** Give the provider the following information as it appears on your ACP application so they can sign you up:
