WE RESPECTFULLY REQUEST ABATEMENT OF LATE FILING PENALTIES FOR REASONABLE CAUSE, PURSUANT TO IRC SECTION 6652(C).

WE BELIEVE OUR ORGANIZATION EXERCISED ORDINARY BUSINESS CARE AND PRUDENCE IN MEETING OUR FILING OBLIGATIONS. WE ENGAGE A CPA FIRM TO ASSIST IN THE PREPARATION AND FILING OF OUR ANNUAL FORM 990 AND RELATED EXTENSIONS, AND TO AUDIT OUR ANNUAL FINANCIAL STATEMENTS. DURING 2024, 2025, AND 2026 LITERACY MINNESOTA EXPERIENCED SIGNIFICANT, REPEATED, AND UNEXPECTED TURNOVER OF THE KEY PERSONNEL RESPONSIBLE FOR GATHERING AND PROVIDING FINANCIAL INFORMATION, AS WELL AS A MAJOR AND DIFFICULT SOFTWARE SYSTEMS OVERHAUL. AS A RESULT, THE AUDIT AND TAX RETURN FOR FISCAL YEAR JUNE 30, 2024 WERE DELAYED. AS SOON AS INFORMATION WAS AVAILABLE, IT WAS PROVIDED TO THE CPA FIRM FOR COMPLETION OF THE AUDIT AND TAX FILINGS.

PRIOR TO THE FISCAL YEAR ENDED JUNE 30, 2024, OUR ANNUAL RETURNS HAVE BEEN TIMELY FILED. IN ADDITION, THE JUNE 30, 2024 RETURN WAS TIMELY EXTENDED BEFORE NOVEMBER 15, 2025. IT IS ALWAYS OUR INTENTION TO MEET IRS FILING REQUIREMENTS, AND THE FAILURE TO FILE TIMELY WAS NEITHER INTENTIONAL NOR THE RESULT OF WILLFUL NEGLIGENCE; RATHER, WE WERE UNABLE TO COMPLETE THE FILING TIMELY DUE TO EXCEPTIONAL, UNEXPECTED CIRCUMSTANCES.
