Community needs assessment survey

PURPOSE OF SURVEY:

The COVID-19 pandemic has exacerbated racial and economic disparities in digital equity, from K-12 students lacking reliable access to the internet for distance learning, to newly unemployed adults whose access is limited to a mobile device for completing online job applications, and more.

Literacy Minnesota [https://www.literacymn.org/] in collaboration with the Minnesota Department of Education [https://education.mn.gov/MDE/index.html] is conducting a Community Needs Assessment to learn about how the COVID-19 pandemic has changed the ways that participants access education and to identify digitally underserved communities. Northstar Digital Literacy [https://www.digitalliteracyassessment.org/], a program of Literacy Minnesota, has sought to close the digital divide for 10 years by offering digital literacy assessments and curricula.

Responses to this Community Needs Assessment survey will contribute to a report that will be publicly available after January 2021, and will be used to inform two pilot projects currently in planning stages. Both projects would support K-12 students and adult learners:

- 1. A "digital navigator" project in Minnesota to provide targeted assistance to individuals in the areas of connectivity, device access and digital literacy to close the digital divide;
- 2. A multi-state digital equity project in the North Central region (MN, IA, WI, ND, SD, NE, MO, KS), potentially adding more states in the future, that would place AmeriCorps volunteers in nonprofits, schools and public agencies to help them increase digital equity in low-income communities, such as:
 - scaffolding curricula for beginning ELL or transitioning curricula for online learning
 - creating resources and workshops to help parents support their children with distance learning/learning at home
 - generating funding and other resources
 - o recruiting and training virtual tutor volunteers
 - o or other digital equity projects identified by the host organization

- In Minneapolis and St Paul, MN: free classes for adults, a literacy-rich preschool for children of adult learners, and parenting classes
